INFORMATION TO PARENTS (Please read carefully)

Registration Procedures: –

- Parents are invited to register their child/children in order to ensure their participation. Registration form is also available at the MSC or on its website (<http://www.mauritiussportscouncil.com/English/Pages/default.aspx>)
 - Registration should be made on prescribed form for appropriate dates. Incomplete registration may penalize your child/ children.
 - Parents/guardians will be requested to pick up child in case of suspected illness or infection as soon as possible in order to safely reduce the risk. of a spread throughout the camp. A child recovering from illness (infection) will not be accepted. Injured kids will not be accepted.
 - During the Camp, children should use appropriate sports wear that is comfortable and in which they can freely move, as well as appropriate footwear (TRAINERS). **PLEASE NOTE THAT CHILDREN WILL PERFORM ACTIVITIES BAREFOOTED IN THE SPORTS HALL.**
 - Participants are encouraged to bring a spare t-shirt and a clean towel.
 - Swimming gear (one piece) and Swimming cap are mandatory for swimming activities.
 - Participants should not bring valuable objects and important sum of money. The organizing body will not be responsible for any damage or loss.
 - Staff will monitor and control behaviour order to ensure the smooth running of the programme and the security of all children.
 - We recommend light meals during the sports camp. No soft drinks will be allowed.
 - The time schedule for activities for the camp are from 0900 to 1200 hours, so the drop-off in the morning is between 0830 to 0845 hours and then pick up is usually from 1200 up to 1215 hours.
 - All parents / carers are kindly requested to pick up their children not later than 1215 hours.
 - Provision will be made for shuttle buses from St Pierre bus station to Cote d'Or as per scheduled below:
 Departure from St Pierre 0800 hours – Arrival at C. D'or 0820 hours
 Departure from C. D'Or 1210 hours – Arrival at St. Pierre 1230 hours
- The following activities are proposed:
1. Classic Games/Traditional Games (outdoor).
 2. Fun Team Games and Basic Gymnastics in the Sports Hall.
 3. Swimming and Fun Water-Based activities in the training pool.

Parents are most welcome to attend and support their child/children but should at all time be in the public stand.
